Cookies Policy

This policy is effective as of 5th of December 2023. This privacy statement can be updated from time to time.

The Website "https://www.znd.co" uses cookies to improve the operation of the Website, increase the comfort of browsing and protect Users. More information on cookies and how to manage them can be found below.

Definitions

For the purposes of the Cookie Policy, we will use the following definitions:

- **User** a person using the Website;
- **Website** means the website https://www.znd.co
- Administrator means ZND.CO OÜ with its registered office in Harju maakond, Tallinn, Lasnamäe linnaosa, Tähesaju tee 9 (office No 7, 2nd floor), 11415 Estonia

What are cookies and what are they used for?

- 1. Cookie files (cookies) are IT data containing information (in particular text files) saved by the server on the User's computer, which the server can read when the User reconnects to the Website from such a computer. Cookies usually contain the name of the Website they come from, the end device's storage time, and a unique number. Cookies managed by Administrator only are called "first party cookies" whereas cookies from third parties are called "third party cookies".
- 2. Cookies are used for the following purposes:
 - a) adjusting the content of the Website to the User's preferences and optimizing the
 use of the Website; in particular, these files allow to recognize the device of the
 User and properly display the Website, tailored to his individual needs;
 - b) creating statistics that help to understand how Website Users use it, which allows improving its structure and content. We can identify User's behavior and present content and marketing offers based on the User profile.
 - c) maintaining the Website user's session (after logging in), thanks to which the User does not have to re-enter their login and password on each subpage.
- 3. The Website uses two basic types of cookies: "session" and "persistent" cookies. Session cookies are temporary files that are stored on the User's end device until logging out, leaving the Website, or turning off the software (web browser). Persistent cookies are stored on the User's end device for the time specified in the parameters of cookies or until they are deleted by the User.

- 4. The Website uses the following types of cookies that perform various functions presented below:
 - a) Strictly Necessary Cookies These cookies are necessary for the website to function and cannot be switched off in our systems. They are usually only set in response to actions made by you which amount to a request for services, such as setting your privacy preferences, logging in or filling in forms. You can set your browser to block or alert you about these cookies, but some parts of the site will not then work. These cookies do not store any personally identifiable information.;
 - b) **Targeting Cookies** These cookies may be set through our site by our advertising partners. They may be used by those companies to build a profile of your interests and show you relevant adverts on other sites. They do not store directly personal information but are based on uniquely identifying your browser and internet device. If you do not allow these cookies, you will experience less targeted advertising.
 - c) **Functional Cookies** These cookies enable the website to provide enhanced functionality and personalization. They may be set by us or by third-party providers whose services we have added to our pages. If you do not allow these cookies then some or all of these services may not function properly.;
 - d) **Performance Cookies** These cookies allow us to count visits and traffic sources so we can measure and improve the performance of our site. They help us to know which pages are the most and least popular and see how visitors move around the site. All information these cookies collect is aggregated and therefore anonymous. If you do not allow these cookies we will not know when you have visited our site, and will not be able to monitor its performance.

Who and how manages cookies?

- As an authorized entity, the administrator places and manages "first-party cookies" on the User's end device. Some cookies and other tracking and storage technologies that we use are from third-party companies ("third-party cookies") to provide us with web analytics and intelligence about our sites which may also be used to provide measurement services and target ads.
- 2. The Website automatically collects information through cookies. If you do not change the settings for cookies, it is considered consent to their use.
- 3. Using a web browser, the User may change the cookie settings at any time and disable some or all cookies.
- 4. Restrictions or exclusions in the use of cookies and other similar technologies may affect some of the functionalities available on the Website.

- 5. In the event of disabling one or more cookies, the Administrator continues to use the information obtained from previous cookies before the User sets cookies to be disabled or limited. From then on, the Administrator will not use cookies that have been disabled to collect any new data.
- 6. The Administrator reserves the right to change the Cookie Policy and at the same time undertakes to immediately publish the changes on the Website.
